#### Introduction

This report provides up-to-date data and analysis on the situation of human rights in Kurdistan of Iran from January 1, 2018 until October 31, 2018, prepared for the attention of the UN Special Rapporteur on the situation of human rights in Iran, UN agencies, media, governments and public attention.

The current Islamic Republic administration pledged to improve and reconsider its security approach toward Iranian Kurdistan both during the first round of Hassan Rouhani's presidency, as well as during his victorious presidential campaign, which took place in early months of 2017. Nevertheless, thus far in 2018 the persecution, execution, imprisonment and indiscriminate and blind killings of *Kulbaran* (border couriers or tradesmen) remain alarmingly high. This report specifically addresses executions, political prisoners, indiscriminate killings of *Kulbaran* (Border Couriers) and landmine incidents affecting Kurdish civilians from January 1, 2018 to October 31, 2018.

Every year KMMK-G provides the details of data collected in each aforementioned category in Persian attached to its annual human rights violations in Kurdistan report.

#### Background

#### **State-Sponsored Violence and Discriminations against Kurdish Citizens**

Kurdistan, the country of the Kurds, is divided among Iran, Turkey, Iraq and Syria. Iranian Kurdistan covers an area of 111,705 km2, comprising four western provinces of Kermanshah, Ilam, Wermê (West Azerbaijan) and Kurdistan, situated in northwest Iran. Their population is estimated between 11–13 million people. Most of the Kurds are Muslims: 66% Sunni, 27% Shi'a and the others are: Yarasan, Yazidis, Qadiriyya, Naqeshbandiyya, Christian and Jew.

Iranian Kurdistan like Iranian Baluchistan, Ahwaz and Turkmenistan suffer a high level of unemployment and discriminatory policies of "the gozinesh", religious monitoring based on one specific sect of Islam. According to the UN Committee on Economic, Social and Cultural Rights, the Iranian 1995 Selection Law based on Religious and Ethical Standards known as the "gozinesh "impairs the equality of opportunity or treatment in employment for persons belonging to ethnic and religious minorities.

Despite the diversity of ethnic constituents of Iran, only the Persian-Shiite group holds ultimate state power, and Article 1 of the Constitution of the Islamic Republic of Iran declares the Twelver Shi'a School of Islam as the formal religion of the state.

The current government maintains the policies of its predecessors and adheres to a system of governance based on the ideology of one country, one nation, one language and one religion. These elements perpetuate systemic and systematic discrimination against and repression of all ethnic nationalities and religious minorities in the country. Governmental participation by members of ethnic nationalities or religious minorities such as Kurds, Sunni Baloch people, Yarasan or Baha'is is severely



restricted, preventing such individuals from assuming the presidency or occupying any significant governmental position.

#### **Recent Developments: General Strikes in Kurdistan**

In recent months a general strike by Kurdish citizens emerged in Kurdistan of Iran in response to a number of recent developments such as the execution of 4 Kurdish political prisoners, the Iranian Islamic Revolutionary Corps' missiles attacks on the headquarters and adjacent refugees' camps of Democratic Party of Iranian Kurdistan in Erbil (Iraqi Kurdistan) on September 8, 2018. Thousands of Kurdish shop keepers shut down theirs markets in Sannadij, Saqez, Baneh, Mariwan, Ashnavia, Mahmabad, Kamiaran, Sarpoolzahab, Kermanshah and many other towns.

Similarly, in objection to a decision of the government of the closure of the border, the inhabitants of Baneh initiated a general strike in April 2018, shutting down their shops and organizing public peaceful sittings in both Baneh and Mariwan. The government's response to both general strikes was crackdown on peaceful strikers and the detention of 120 Kurdish shop keepers and protestors were arrested.

#### Methodology

The Iranian authorities refuse to provide accurate data on executions, landmines, Kulbaran (border couriers) and other issues. In order to get the most credible data, KMMK-G collects and verifies up-to-date information in the following ways: (a) conducting interviews with the family of the victims, (b) conducting interviews with the lawyers of the victims, (c) contacting and receiving information from various institution, on-the-ground local networks, as well as informants within authorities and governmental entities, (d) monitoring the Islamic Republic's official statements, state media and publications, (e) receiving information from informal news agencies, and (f) partnering with the Human Rights Section of Kurdpa News Agency in obtaining on-the-ground information.

#### I. Executions

The data collected by Broroumand Foundation indicates that in the period of January 1 till October 31, 2018 over 200 prisoners were executed in Iran.<sup>1</sup> According to the data collected by the Association for Human Rights in Kurdistan of Iran-Geneva (KMMK-G) from January 1 to October 31, 2018 at least 53 Kurdish prisoners have been executed (*Annex 1- KMMK-G's List of Kurdish Prisoners Executed from January 1 – October 31, 2018*).<sup>2</sup> Nearly a quarter (15 out of 53) of the executions of Kurdish prisoners take place outside Kurdish regions.


At least a quarter of the overall number of executions in Iran belong to the execution of the Kurds thus far in 2018. In 2017, the Kurdish executions, which was a total of 71 according to KMMK-G's data, constituted one fifth of the all executions in Iran. There is also an increase of the number of executions of Kurdish political prisoners; according to KMMK-G's data the number of executions related to belief and political opinion were 10 in 2017 while this number is thus far 29 in 2018.

In this context, despite an noteworthy decrease in drug-related executions in the country and the fall of the number of the executions as a whole from 500 to 200 in 2018, the Kurdish share of executions is increasing dramatically and disproportionally.



Executions of Kurdish Prisoners in Iran from January 1- October 31, 2018

Even the three Kurdish prisoners (Hossein Panahi, Zanyar Moradi and Loghman Moradi) whose cases were specifically highlighted by the UN, urging the Islamic Republic of Iran to annul death sentences against them, were executed on September 8, 2018. Statement made by the UN Special Rapporteur on arbitrary executions, Agnes Callamarad, and the UN Special Rapporteur on the situation of human rights in Iran, Dr. Javaid Rehman, indicated concerns over these individuals not having received fair trial, while also having been tortured in detention.<sup>3</sup>Similarly, referring to the aforementioned three executed Kurdish prisoners in his October 2018 report, Dr. Javaid Rehman, urged the government to afford all people in the country equal rights, including during and all stages of criminal proceedings as set out in Article 19 of the Constitution of Iran.<sup>4</sup>

#### II. Political Prisoners

Similar to previous years, the share of Kurdish political imprisonment remains dramatically high in first ten months of 2018 (until October 2018). According to on-the-ground findings of KMMK-G, Kurdish political prisoners represent almost half of the total number of political prisoners in the country.<sup>5 6</sup>

Given the nature of mass arrests that have taken place in response to strikes and protests in Kurdistan in recent months, data collection for this section has proven particularly difficult. KMMK-G's on-the-ground contacts have collected what they could, information about which is provided in this section.

According to KMMK-G's collected data, 749 Kurdish citizens were detained/arrested from January 1 till October 31st, 2018, many of whom sentenced to long years of imprisonment and were charged with crimes related to civic activism and membership of Kurdish political parties. <sup>7</sup>Among these prisoners, there are individuals who are workers, teachers, *Koulbars* (border couriers), artists, and human rights activists, environmental activists, journalists, lawyer, students, photographer, cultural activists, and others alike.

In this context, according to the data received by KMMK-G, there are 9 civic activists, 4 cultural activists, 5 environmental activists, 1 photographer, 3 journalists, 5 labour activists, 4 students, 1 lawyer, 1 Peshmarga and 83 kulbar (border courier) among those detained. There are also 12 women among the detainees. The absolute majority of the reported detentions/arrests this year are in relation to general strikes in Kurdistan, with intelligence and ddisciplinary forces (Ettela'at and Entizami) cracking down on the strikes and detaining many with the allegations of threats against national security.

For instance, Mr. Taher Tawhidi, a Kurdish lawyer, was sentenced to 17 months of imprisonment, and sent to Sanandij Central Prison on January 17, 2018. He was charged with the crime of "insulting the governmental civil servants and spreading lies". He was trialed by Section 106 of the Sanandaj Penal Tribunal.<sup>8</sup>

Evidently, the Kurdish community remains one of the most suppressed groups in the country, with individuals being persecuted, arrested and in many cases sentenced to death due to their alleged activism.

#### III. Indiscriminate Killings of Kulbaran (border couriers or tradesmen)

Even though the current Islamic Republic administration pledged to change its security approach toward Iranian Kurdistan, the indiscriminate killing of Kurdish Kulbaran (border couriers or tradesmen) has increased in 2018. The indiscriminate and blind killing of Kurdish Kulbaran (plural for Kulbar) takes place in blatant violation international obligations. Border security forces involved in indiscriminate and blind killings do not even respect Iranian domestic laws, which authorize the use of lethal force only as a last resort.


KMMK-G has received reports of indiscriminate and blind killings of 63 border couriers known as Kulbar from January 1 till October 31, 2018, with another 134 individuals working as Kulbar injured at the border due to reasons such as shooting and landmine explosions among others. This brings the total incidents reported regarding shootings and discriminate killings of Kulbaran to 197 during the time period of discussion (*Annex 2- KMMK-G's List of Injuries, and Indiscriminate and Blind Killing of Kulbaran from January 1- October 31, 2018*). Moreover, many kulbaran (tradesmen) were arrested and their goods were confiscated by the authorities thus far in 2018. In addition, hundreds of horses belonging to Kurdish Kulbaran were also shot dead.

The chart below shows the increase in numbers in the past two years, when comparing the same time period in 2017 and 2018. Additionally, according to KMMK-G's data, with a total of 122 instances of border courier attempts for indiscriminate and blind killing of Kulbaran by the border, 51 Kulbars were killed and 71 were injured in 2016. This data reveals that the number of kulbaran killed and injured by security forces in 2016 for the full year was less than the number of kulbars injured and kills during the first ten months of 2017 and 2018.

Due to high rates of unemployment, and land contamination caused by landmines and explosive remnants of the Iran-Iraq war that hamper seriously the daily life of civilians particularly the farmers, the nomads, the shepherds and traders, the Kurdish youth and farmers from four Kurdish provinces of Kermanshah, Kurdistan, Ilam and Wermê (West Azerbaijan) engage in smuggling commodities, such as tea, tobacco and fuel to earn a living. As the 26-year-old Taha Ghaffari, Iran's champion in track and field who has also received medals in Asia, and yet still working as a Kulbar in Iranian Kurdistan (Marivan) to support his family told the state-run Fars News in a recent interview, "Kulbari [Being a Kulbar] is not a profession. It is an obligation to feed your family and sustain their livelihood."<sup>9</sup>

#### IV. Landmine Incidents Affecting Kurdish Civilians

Various international bodies and entities such as the Working Group on the Universal Periodic Review (UPR) on Iran (2010) and the Committee on the Rights of the Child (January 2016) have made observations and recommendations, urging the Islamic Republic to clear its territory of landmines and all the remnants of the Iran-Iraq war (1980-1988). Nevertheless, despite international and domestic efforts, the Islamic Republic refuses to cooperate with international NGOs and entities, and to ratify the Ottawa Mine Ban Treaty.

According to KMMK-G's data, thus far this year (January 1, 2018 till October 31, 2018) at total of 41 Kurdish citizens have been the victims of landmine explosions; 11 Kurdish civilians were killed and 30 were wounded due to landmines expositions and unexploded remnants of the Iran-Iraq war, which ended a long time ago in 1988 (*Annex 3- List of the Incidents and Victims of Landmine Explosions in Kurdistan of Iran from January 1 to October 31, 2018*). The majority of the victims are koulbars (border couriers). Two children aged 10 and 12 are among the injured victims. 11 of those injured are women. Most of the explosions took place in Sanandaj and Kermanshah. Most of the injures are in the foot, hand and eyes.

It is also important to note that according to Iranian official statistics, during to eight years-long Iran-Iraq war (1980-1988), more than 20 million landmines have been planted in Iranian Kurdistan and Khuzestan province that hamper seriously the daily life of civilians particularly the farmers, the nomads, the shepherds and traders. Essentially, an area of about 4 million and 200 thousand hectares is contaminated by mines and explosive materials.

Iranian Kurdistan is the most affected area by landmines and undetonated ammunitions. The reason for this was armed conflict of 1980-1993 between government forces and Kurdish combatants. Reportedly, the Iranian Army planted



unknown number of mines around their barracks and compounds in many villages and cities in Kurdistan.

#### Conclusion

The Islamic Republic does not seem even remotely willing to stop its outrageous human right violations. Iran's policy of instilling fear and intimidation among members of ethnic nationalities, in particular Kurds, remained actively and aggressively in place thus far in 2018. Meanwhile, the emergence of the Kurds as an inevitable part of a viable solution to a stable Middle East increases Islamic Republic's paranoia of its Kurdish populations at home, despite Kurds' modest request for equality and federalism.

Iranian president, Hassan Rouhani, who calls himself a "moderate" and a "reformist" and highlights human rights, has failed to live up to his promises, including minority rights. Even his most promising gestures, such as allowing university students to officially enroll in Kurdish language studies, are inherently symbolic in nature. Regardless, the power is not in the hands of *elected* governments in Iran, especially when it comes to matters of national security such as Kurdish rights. The Supreme Leader, Ali Khamenei, as well as the Islamic judiciary and the Islamic Revolutionary Guards Corps (IRGC), fear even the slightest signs of empowered ethnic communities, Kurds in particular. Yet, the Supreme Leader remains the ultimate decision-maker of the country. In short, despite repeated calls from the United Nations to the Iranian authorities in regard to human rights violations, the Islamic Republic's policy to suppress Kurdish populations remained as forceful as ever in 2018.

Recent general strike in Kurdistan emerged in 2018 attest to the growing frustration of ordinary Iranian citizens with economic and political hardships in the country. Instead of effectively addressing these grievances, the Islamic Republic responds by detaining peaceful protestors and intensifying existing repressive measures.

KMMK-G has regular media outreach to Kurdish and Persian media and sponsors cultural events for the Kurdish community in Europe.

As a part of its advocacy efforts, KMMK-G is hosting regularly panels and seminars in Human Rights Council sessions in Geneva and as well as at the Swiss and EU Parliaments to promote the rights of ethnic groups in Iran. In previous years, the group partnered with Geneva Graduate University and Impact Iran to organize workshops on the rights of Iran's ethnic groups and also a panel at Human Rights



Council with the participation of the former UN Special Rapporteur for Iran (Dr. Ahmad Shaheed) and Dr. Shirin Ebadi the Peace Nobel Laureate.
